This Privacy Policy applies to the Eureka website operated by Eureka at www.eurekaretailsolutions.com and related pages (the "Eureka Website") and governs data collection, usage and protection by Eureka.

Collection of your Personal Information

Eureka collects personally identifiable information, such as your e-mail address, name, address, employer, and telephone number. Eureka may also collect other information designed to help Eureka provide services and information to you such as your product preferences.

Information about your computer hardware and software is automatically collected by Eureka for the operation of the Eureka Website and service, to maintain quality of the Eureka Website and service, and to provide general statistics regarding use of the Eureka Website. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses.

Eureka is not responsible for the privacy statements, terms and conditions, or other policies or content on websites outside of the Eureka Website, or for any use of personal information or data collected by such third party websites, regardless of whether links to such third party websites are provided on the Eureka Website.

Use of your Personal Information

Eureka collects and uses your personal information to operate the Eureka Website and deliver the services or products you have requested. Eureka may also contact you via surveys to conduct research about your opinion of current products or services or of potential new products or services that may be offered.

Eureka does not use, share or disclose any personally identifiable information about you without your explicit consent. By entering personally identifiable information and demographic information in the Eureka Website, you consent to Eureka using such information in connection with the operation of the Eureka Website and to contact you and/or to provide features and services to you through the Eureka Website. Eureka keeps track of the Website pages our customers visit within Eureka, in order to determine what Eureka products and services are the most popular. However, Eureka will not sell or share any personally identifiable information about you to any third party without your prior explicit consent. Eureka may however use and share aggregated data and information that provides aggregated or overall data and statistics, but which is not traceable to any particular individual or Eureka Website user and does not contain any personally identifiable information that would connect such aggregated data and information to any particular user or customer.

Eureka does not sell, rent or lease its customer lists to third parties. Eureka may contact you on behalf of external business partners about offerings that may interest you, but your unique personally identifiable information (i.e. e-mail, name, address, telephone number, etc.) is not transferred or disclosed to any third party.

Notwithstanding the foregoing, Eureka may share data and information with trusted partners in certain circumstances as necessary to help us perform statistical analysis, send you email or postal mail, provide customer support, arrange for deliveries, or otherwise provide services requested by you through the Eureka Website. All such third parties are prohibited from using your personal information except as necessary to provide these services to Eureka, or to you through Eureka, and they are required to maintain the confidentiality of your information.

Eureka will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Eureka or the Eureka Website; (b) protect and defend the rights or property of Eureka; and, (c) act under exigent circumstances to protect the personal safety of users of Eureka, or the public.

Use of Cookies

Eureka websites use "cookies" to personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. You have the ability to accept or decline cookies through your web browser's settings. If you choose to decline cookies, you may not be able to fully experience the interactive features of the Eureka Website.

Security of your Personal Information

Eureka secures your personal information from unauthorized access, use or disclosure, storing personally identifiable information users provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure. When personal information is required to be transmitted to other parties or websites, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol.

Data Breach
